BY RAIL

The North Campus is a 15-minute walk from Maynooth train station.

Maynooth lies on the Western Commuter Line serving four Dublin city centre stations (Pearse Station, Tara Street Station, Connolly Station and Docklands) as well as thirteen other suburban stations (Drumcondra, Broombridge, Pelletstown, Ashtown, Navan Road Parkway, Castleknock, Coolmine, Clonsilla, Hansfield, Dunboyne, M3 Parkway, LeixlipConfey and LeixlipLouisa Bridge).
